All job ads are reviewed by the OAVT before being posted. References to 'veterinary technician' or 'vet tech' are not permitted and will be adjusted to reflect Registered Veterinary Technician.

Job ads must be purchased online, by credit card, before they can be submitted for review.

All job ads are posted for 60 days from the date of submission.

7. Pricing

Job ad packages include access to all customizations. Featured job ads are highlighted to stand-out from other posts. All Prices are listed in Canadian Funds and exclude tax. Tax is calculated based on the Job Ad account billing address.

Prices are subject to change at the OAVT's discretion and will be updated accordingly on the OAVT Job Board.

8. Payment Methods
