

TERMS AND CONDITIONS FOR ONTARIO ASSOCIATION OF VETERINARY TECHNICIANS "2025 RVT MONTH DRAWS"

Your participation in The Ontario Association of Veterinary Technicians (OAVTs) 2025 RVT Month Draws ("The Draws") shall be deemed to be your complete acceptance of the Terms and Conditions herein. The following are the Terms and Conditions of The Draws:

- 1. Only persons over the age of 18 are eligible for entry to The Draws. You may be asked, at any stage, to provide OAVT or a third party with proof of age and /or identity.
- 2. No purchase or payment at any time is necessary to enter or win.
- 3. The Draws shall take place (October 1 to October 31, 2025).
- 4. The odds of being selected as a winner depend on the number of entries received. The winner will be randomly selected from the pool of entries.
- In order to enter The Draws, the entrant must be an RVT member in good standing with the OAVT.
- 6. OAVT employees, sponsors, and affiliates' employees and their immediate family members are not eligible to participate.
- 7. Each entrant shall be entitled to make one (1) entry into The Draws only. In the event that the OAVT deems an entrant to have made multiple applications to enter or to have acted in bad faith with respect to the Promotion, the entrant shall be excluded from The Draws and consequently ineligible to win the Promotional Prize, as defined below.
- 8. The Prize for winning a draw shall be a \$250 digital gift card from a select list of available cards.
- 9. There is no substitute for The Prize.
- 10. The winner must be an RVT in good standing (as defined by the OAVT) to receive their prize.
- 11. The OAVT shall notify the winner via E-mail within five (5) days of The Draws.
- 12. In order to claim The Prize, the winner must successfully answer a skill testing question.
- 13. The Prize will be delivered by email.
- 14. Notwithstanding Section 12 above, in the event that, for any reason whatsoever, The Prize winner fails to respond, within seven (7) days, to the email notification, such winning entrant shall be deemed to have forfeited the claim to The Prize and the OAVT shall not have any obligation whatsoever to compensate the winning entrant in any way.
- 15. The OAVT's decision is final with respect to all matters relating to awarding of The Prize and shall not be subject to review or appeal by any entrant or by any third party.
- 16. An entrant's participation in The Draws is considered their agreement that the OAVT may contact them.
- 17. The Prize is neither transferable nor exchangeable and cannot be exchanged for money or money's worth.



- 18. By submitting a photo for RVT month, and subsequently entering the Draws, each entrant unreservedly agrees to these terms and conditions, which govern the Draws and the awarding of The Prize.
- 19. By entering the Draws, each entrant agrees to release, discharge and hold harmless the OAVT, its legal representatives, affiliates, subsidiaries, agencies and their respective officers, directors, employees and agents from any damages whatsoever suffered or sustained in connection to The Draws or the acceptance of The Prize.
- 20. The winning entrant shall be solely responsible for any taxes levied in relation to the delivery or receipt of The Prize.
- 21. The OAVT, in its sole discretion, reserves the right to alter these Terms and Conditions at any time.
- 22. The OAVT reserves the right to, at any time, cancel, modify or suspend The Draws if, in its sole judgment, The Daily Draws can't be conducted as specified.
- 23. The OAVT reserves the right to disclose a winner's name and identity.
